PUBLIC NOTICE NO. 02 /2020

SUBJECT: OPERATIONALIZATION OF THE CUSTOMS STATION AT ANGOOR ADDA.

The MCC-Appraisement & Facilitation, Peshawar is pleased to announce for information of the importers, exporters, clearing agents, trade bodies, all govt. departments and organization that the Customs Station (CS) Angoor Adda located at Pak – Afghan border, South Waziristan shall be reopened/operationalized for the clearances of bilateral trade cargo (imports/exports) consignments from/to Afghanistan with effect from 23-09-2020.

2. The following procedure/instructions are to be followed for clearance of trade cargo from the C.S. Angoor Adda:-

- (i). The imports shall be carried out against mandatory submission of "Form-I"
- (ii). The clearance of exports cargo shall be allowed against furnishing of "Form-E";
- (iii). The clearance of import cargo shall be allowed initially through ACL in terms of Section 34 of the Customs Act, 1969 until formal establishment of the banking facility at the Station;
- (iv). The ACL accounts maintained by the importers/exporters/clearing agents for clearance of cargo from the C.S. Tank shall also be operative at the C. S. Angoor Adda until further orders;
- (v). All other operative Customs Procedures, CGOs and the Customs Rules alongwith Imports/Exports Regulations notified through Imports & Exports Policy Orders shall also be applicable on cargo cleared from C.S. Angoor Adda;
- (vi). The processing of imports GD at Tank shall remain operative until 30-09-2020. Thereafter, import GD shall not be processed or allowed clearance from the Customs Station Tank.

3. The residents of South Waziristan District who are interested to have Custom House Agents License (CHA) may apply on prescribed application form to the Collector, MCC-Appraisement & Facilitation, Peshawar for grant of provisional CHA License to eligible persons. Moreover, importers, exporters and clearing agents are also requested to register themselves under


