The Office of the Directorate General of Trade Organizations, vide its notification F.No. 12(1)/2025-Policy dated 30th March 2026 (copy enclosed) is pleased to notify that the deadline for renewal of membership of all Trade Organizations registered under the Trade Organizations Act 2013, is extended from 31st March 2026 to 20th April 2026.

The esteemed office of the DGTO, clarified that this facilitation pertains exclusively to the membership renewal deadline and does not affect the ongoing enforcement of annual reporting requirements.

Furthermore, as per directives of the esteemed Office of the DGTO, the Secretary Generals of Registered Trade Organizations are advised to please read the enclosed notification / document and its contents very carefully, and ensure the renewal process is completed with due diligence, particularly regarding the verification of tax returns as required under Rule 11 and; to prepare their preliminary voters' lists based on the updated renewal data, ensuring full compliance with the requirements of Rule 15 and Rule 18.
