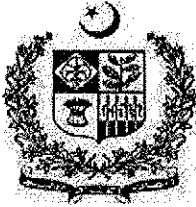


ORDER
